It is the policy of Franklin Road Academy to award aid to students based on the evaluations made by FACTS Aid Assessment based in Lincoln, NE. FACTS is a leader in need-based financial aid analysis and operates in accordance with Franklin Road Academy's guidelines.

Financial aid awards will be considered as soon as possible once a completed analysis has been received from FACTS. Applicants are encouraged to apply as soon as possible. The Financial Aid Committee will begin evaluating financial aid applications in February and will contact the parent /guardian once a decision has been made. **Current FRA families should submit completed Financial Aid Applications no later than April 30, 2012.**

Financial aid application and verification must be completed by April 30, 2012. If applying for admission after April 30, the financial aid application and verification deadline is July 1. Later applications for admission and financial aid will be considered as enrollment places and funds are available.

Financial aid is granted on a yearly basis and is not assured from one year to the next unless specifically stated through the administration of a scholarship endowment or other such program. Financial aid information is strictly confidential. The members of the selection committee are not made public; however, inquiries may be directed to the Business Office.
